Dear New Member;

Welcome to THE "GATHERING". I want to thank you for taking the time to fill out this application and joining your brothers and sisters in this Gathering of the Lost American Indians. Our mission has been to establish tribal rights in our membership organization, for anyone that has American Indian blood.

Most Native people who do not belong to a tribe or cannot get on closed Federal Government rolls are left to fend for themselves. Because of political policy within the tribes themselves it is difficult for those not born on the reservation or who have left their tribal homelands to get established back into any tribal organizations. By filling out the following paperwork you are establishing that right to be recognized as an American Indian within the United States and Canada.

The United Indian Nation will accept any and all American Indians who state and claim their native heritage. After reviewing your application and documentation for acceptance, members will be issued a tribal membership card and certificate. Although you will be attached to a Clan Chief in your state, the tribal ID Cards will be sent from the National Office.

This ID Card and certificate remain the property of the The United Indian Nation at all times and are protected under the following Acts:

The American Indian Religious Freedom Act of 1978.

The Free Exercise Clause of the lst Amendment.

The Free Exercise Clause of the 1968 Indian Civil Rights Act.

Take the time to carefully review the application information and <u>make sure you make additional copies of all forms</u> not only for you, should you make mistakes in filling them out, but for anyone you know that has Indian blood. All funds and donations should be mailed to National and International/ Principal Chief Larry "Rabbit" Riddle, at The United Indian Nation National Office, not to your local Clan Chiefs. Once our National Office has reviewed your application we will send a notice of acceptance along with your new tribal membership ID card.

I look forward in communicating with each of you for which I am responsible. As the National / Principal Chief I will assist and do everything possible to keep you informed and up to date on events within the Tribe, please check the website frequently. My phone is always on should you have questions. Please call after 7:00 PM Eastern Standard Time Zone during the week or on weekends or email me any time.
